iiNet is pleased to announce the raising of \$2.2 million through the exercise of options and provide an update on trading, the integration of previously acquired customers and ADSL growth.

Today iiNet raised \$2.2 million through the exercise of Director and Executive options. The 1.7 million options to acquire iiNet shares at \$1.30 each were exercised and placed with an existing institutional investor. These funds have added to cash holdings which currently stand at \$8 million.

Based on trading to 30 April the Company is pleased to confirm that the result for 2003 is expected to be in the order of 15-20% higher than last year. Recent acquisitions will continue to provide additional bottom line earnings in the 2004 financial year once fully integrated.

iiNet has successfully integrated four acquired customer bases since December. The company is currently integrating Tassie.net and finalising due diligence on the 11,000 customers acquired in NSW/ACT. Due Diligence on the 6,000 customers acquired in the Northern Territory will be completed in June.

iiNet's ADSL customer base has grown from 11,000 accounts as at 31 December to more than 19,500. This is exclusive of 3,000 DSL customers acquired in late February. Half of iiNet's ADSL services are provided to clients outside Western Australia.
